7	extent Plaintiff's breach of contract claim is premised upon alleged copying, displaying,
8	distributing or making derivative use of craigslist content in violation of the craigslist website's
9	Terms of Use.
10	For the reasons discussed at the hearing on February 15, 2013, and the reasons stated in
11	PadMapper's memorandum and reply in support of the motion, PadMapper's motion to dismiss
